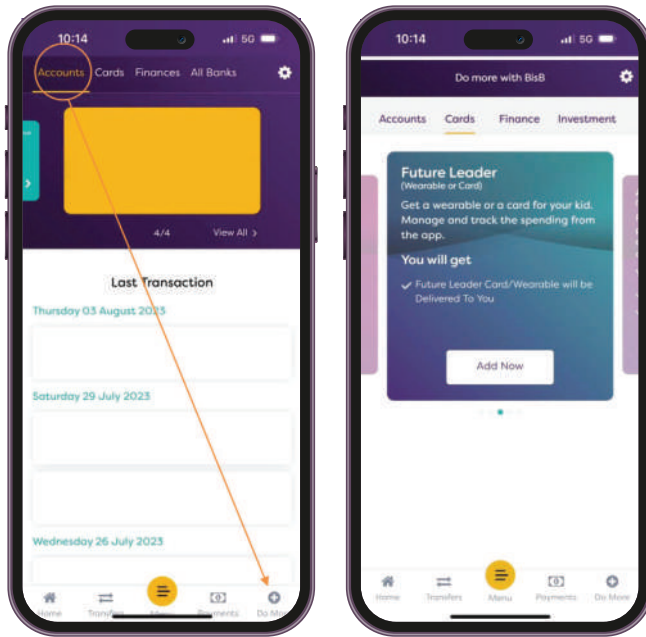


How to Apply?

To Apply:

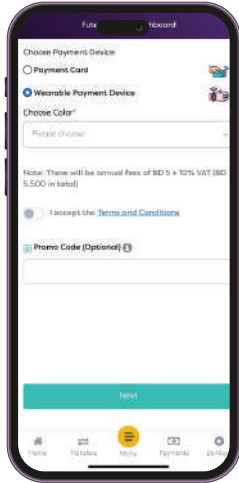
Go to “Do More Section” in BisB Mobile App



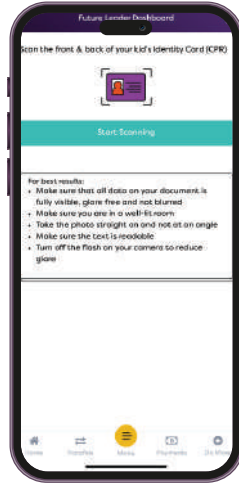
How to Apply?

After Initiating the application, please follow the below steps:

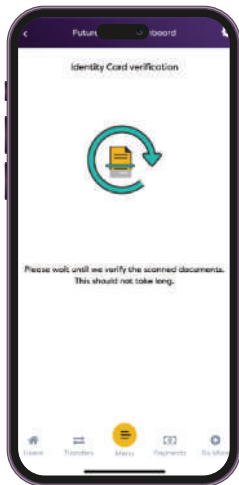
Select Wearable



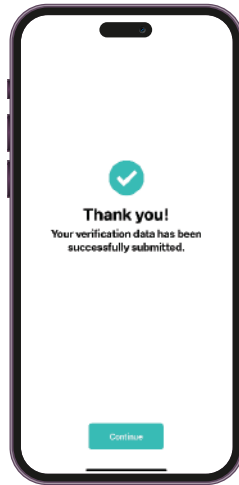
Scan your child's CPR

What is in the Package:

Wrist band

As per your request, you would have received the colour of your choice from the following options:



NFC chip card



How to install the chip in the wearable:

- **Break the chip** (red marked area) from the NFC Chip Card
- **Do not throw away the remaining part** of the NFC Chip card (green marked area) as it contains sensitive information, which is required to activate your card and conduct transactions online.
- **Insert the chip** in the back side of the wearable



There are two options to Activate the card:

Through Mobile App:

- Step 1: The customer will access his/her e-banking and click on the “Cards” from dashboard or under Card Menu.
- Step 2: Choose/click on the required card with the “Inactive status”, click on “Activate” buttons.
- Step 3: Customer enters card CVV number. Customer enters new PIN number. Customers enters confirm new PIN number. System sends OTP to customer registered number & Email. Customer enters OTP. System will verify all details inputted and updates the PIN and activates card.

Or, Through E-Pin portal <https://epin.ebisb.com>

Give the following information:

- **First 6 Digits and Last 4 Digits of your card number**
(Available on the Chip of the NFC Card, on the NFC Card and in the BisB Mobile App under Future Leader Card)
- **Primary Cardholder Smart Card Number** – Parent's CPR number

Once Confirmed, following information is required:

- Enter the OTP which will sent to customer registered mobile & email
- Enter your new PIN
- Re-Enter your New PIN
- Enter your Card Expiry Date (Available on the NFC Chip Card – text marked in red)



- Enter your security code (Available on the NFC Chip Card – text marked in red)



- Confirm to proceed, your PIN is set
Congratulations, You can now use your wearable for contactless transactions

How to conduct transactions using the wearable:

Just bring your wearable device closer to POS machine and your transaction will get processed

You may be asked for a PIN based on value of the amount of transaction as per regulatory requirements. Please use the PIN set at the time of activating the wearable.

How to conduct transactions on Ecommerce:

Use the details on the NFC Chip Card to conduct Ecommerce transactions

Card Number – text marked in green

Expiry Date – text marked in blue

CVV/Secure Code – text marked in red



Please keep this card safe with you at all times and do not share with anyone as it contains Card Number, CVV and Expiry Date. If lost, please call BisB at **17515151** immediately to block the card.
